#### Welcome

The School of Criminal Justice (SCJ) at Michigan State University (MSU) offers online Masters degree programs that cater to professional students seeking a terminal degree, that is, those students not intending to pursue a doctorate degree.

The School of Criminal Justice is committed to providing students with high quality learning experiences. Students enrolled in online Masters degrees typically differ from students enrolled in our on campus Masters degrees in that they seek additional credentials to advance their professional careers and most are <u>not</u> enrolled full-time, but are balancing responsibilities to careers and/or families, in addition to their graduate studies.

As you begin as an instructor in SCJ, we hope you will utilize all of the resources available to you. This orientation is designed to acquaint you with SCJ's online programs and MSU's instructor's resources.

# Introduction to the Program

- Michigan State University's School of Criminal Justice is the oldest and one of the most respected criminal justice programs in the nation. Graduate studies in the School of Criminal Justice began in 1956.

- Students must complete the Masters degree within six years. The semester in which the first class that can be applied to the degree is taken is considered the student's first semester in the program.

# Syllabus Checklist

- **MSU Minimum Course Syllabi Content Required** (as set by MSU Office of Faculty and Organizational Development (F&OD).
  - a) instructional objectives
  - b) instructor contact information and office hours
  - c) grading criteria and methods used to determine final course grades
  - d) date of the final examination and tentative dates of required assignments, quizzes, and tests, if applicable
  - e) attendance policy, if different from the University attendance policy and especially when that attendance policy affects student grades
  - f) required and recommended course materials to be purchased, including textbooks and supplies; and
  - g) any required proctoring arrangements to which students must adhere (effective Spring 2013).

#### Access to D2L, Email, NetID

- Access will be provided once your appointment has been completely processed.
- MSU NetID is used for email and for D2L.
- Once you have access, you will need to enable the course
- Whenever possible, please get D2L enabled prior to the first day of class as many online students are employed and earlier access allows them ample time to prepare and coordinate their work schedules.

- Login with MSU NetID and Password
- Your course(s) will be listed, as well as any communities to which you have been added
- Courses for Instructors (enrollment is under Self Registration)
  - If you have never used D2L, it is recommended to complete the D2L Selfdirected Training
  - Another recommended course is the Best Practices for using D2L to Deliver Quality Instruction
  - Other courses are available: Accessibility for Course Content, Teaching Online by Epigeum, and a Student's Getting Started with D2L (for students)
